 - a. Economic and Benefits Analysis SG – JL/RW/PL Hotwash of meeting July 20 attached – LATE BREAKING EBASG email Monday
Potential Steps: impression that all is well in CBA – no shortfalls?; a few of us track change/comment on their document? Note how many issues are RCSG related and that we are working on this.
Common ground? Appreciate response.
RW - Trying to reduce misunderstandings between areas of RA and RM
Cannot get back on track if address as issues of RAQT. Gross miscommunication.
Intent, do you believe EBASG are influencing RM to full degree ought to.
Change level of discussion – to fundamental idea – rather than tech aspects of RAQT. Ways to improve?
JL – learn from EBA – better job upfront. Take lessons – make clear at very top. Not a methodological guidelines document? Or maybe it is.
Full disclosure ... ? too simple a word? What need to make clear?
Work on better top interface. Not intended to replace ...
Type 1 and Type 2 thinking – Kahneman – Keith Stanovich, Britt ?

Even if very careful of controlling affect, if fully rational, still subject to ‘focul bias’ – EBASG immediate reaction – question our criticism of what they do. They need to convince us RAQT not useful.

RW volunteer to draft a response. Adam Grant – Think Again.

- b. Risk Comm SG – JL Warmwash of meeting August 11 and AJ/WR ppt attached
Potential Steps: get back in touch, reviewed the models, AJ/WR ppt (add to Nature of Social System (Risk ecosystem?), NSF?, their view of concrete step this fall?
Understand models; properties of innovation. Rate of adoption. Or gauge through 5 criteria. AJ/WR – conclude use list how to enable. Work positively on all aspects, then use RAQT – properties to work with .. make clear .. compatible, advantage, 1st bullets in RAQT explain; compare to other guidelines, aspect of compatibility.
RW – bandwidth to engage; not so much.
Instead, strategy would be a draft to EBASG – knock around; send to RCSG results of what we’ve had – RC could comment on draft response. From Comms perspective.
Instead – work with Peg Coleman – positive experience.
Engage with comm group re work we are doing. Use as comm consultants, not academic explanation.
Face present to outside world. How get opening page on SRA web to effectively pull in. Still there on website. Instead ... how get out. What is best outward facing page. Or still limited? But place to start.

Engage with RCSG first. Ask advice.

Meet with RCSG and NSF managers

NSF - \$\$ - to improve model? Or research to monitor? Chris. Application?

Bring up to their head that attends SRA2022. Bob O’Connor. Open to exploration.

Plan ARMSG/RCSG at Tampa. Job is to invest, with good payback. Rough idea. See how to progress.
